## NETWORK SUPPORT SERVICES (VA)

### Program Length/Schedule:

1050 hours/approx. 10 months (full-time)

This program is offered three times a year: January, June & August

Delivery Method: Traditional - 100% classroom-based; Hybrid - Less than 50% of required instruction hours available via distant education (online); Distance - 50% or more instructional hours via distance education (online).

This program is offered 100% online with on-campus labs and finals on Thursdays from 5:30 p.m. - 8:30 p.m.

### Admission Requirements:

- 16 Years of Age or older
- Complete a Program Orientation
- Basic Skills Testing or Exemption
- Interview with Program Counselor/Advisor

### Job Outlook in the Ft. Lauderdale area:

- Demand for Computer Occupations is expected to grow about 6% between 2015 and 2023 (Source: Bureau of Labor Statistics).
- Entry level wages are about \$16/hour (Source: The Florida Department of Economic Opportunity). Actual wages vary according to education, experience and certifications.

### Course Content:

The Network Support Services program prepares students for employment in network administration as network support specialists or provides supplemental training for people previously or currently employed in networking support occupations.

The program prepares students to create, monitor, and maintain computer networks and operate computers and peripheral equipment. Laboratory activities are an integral part of this program. Activities include building and maintaining computers, installing operating systems, configuring routers and switches, and demonstrating mastery through culminating case studies.

Students must enroll in Broward College within 2 years of completing the program at Atlantic Technical College. Additional college credit may be awarded with the attainment of additional industry credentials.
