## BASIC SKILLS TESTING INFORMATION

### Before You Test:

- Once your application and orientation are complete you will be contacted by an ATC registrar for testing.
- There will be no tests given on school holidays or if Broward County Public Schools is closed.
- High school students with an IEP or 504 may utilize classroom/testing accommodations for the testing. If you have an IEP or 504 the ESE specialist will contact you to schedule your testing.
