PRIVATE SCHOOLS AND HOME EDUCATION TECHNICAL PROGRAM INFORMATION

To enroll you must:

- Be a minimum of 16 years of age
- Have achieved a minimum status of 11th Grade
- Have a minimum overall 2.0 GPA (Health Programs require a higher GPA)
- Attend a Career Dual Enrollment Orientation
- Complete the Technical Program Application with required signatures
- Have your application verified and validated by Home Education Personnel, School Board of Broward County (*Home Education only*)
- Register to take the Basic Skills Test *after* you have been approved by a BTC counselor
- Disclose to us if you have an active 504 Plan or IEP (Individual Education Plan) **prior** to testing in order to receive accommodations
- Achieve a score that meets or exceeds the state-mandated basic skills requirements for your selected program

Participate in a personal interview with a Broward Technical College counselor for review of your Basic Skills Test results and specific program requirements
