Section 1 General Institutional Information

Introduction

The three Broward Technical Colleges, Atlantic, William T. McFatter, and Sheridan, are a part of the Broward County Public School System. Their major emphasis is on the development and implementation of occupational training programs designed to meet the needs of business, industry and the community at large, as well as meeting the unique needs of each of its students. It is the right and responsibility of our students to develop their potential while becoming more creative and productive members of society. Our mission is to provide excellence in career and workforce education.

Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) is a federal law that protects the accuracy and privacy of students' education records. Student records are confidential. Parents, guardians, and spouses of students who are 18 years of age or older must have the student's written permission to inspect and review any and all official records. Parents/guardians of students 17 years of age or younger may review their child's records upon request. The Family Educational Rights and Privacy Act, Florida Statutes (F.S.) 1002.22 and 1002.221, and School Board Policy 5100.1 affords parents, guardians, or eligible students certain rights with respect to the student's education records. An "eligible student" means a student who has reached the age of 18 or who is attending a postsecondary institution at any age. Once a student becomes an "eligible student," the rights afforded his or her parents under FERPA transfer to that student. Cost of Attendance

The cost of attendance (COA) budget is based on full-time enrollment and is an estimate of what it will cost you to attend school. This estimate includes tuition and fees, living expenses, books and supplies, transportation and other personal or miscellaneous expenses.

Full-time enrollment for the academic year consists of 900 clock hours and 30 weeks. All awards for less than a full academic year are prorated. This is a sample 900 clock hour/30 week student budget based on full-time enrollment.

Tuition estimates are based on the WorkForce Education Fund as governed by FL Statute 1009.22.

Supply Fee estimates are based on the average supply fee cost for ATC, MTC, and STC.

Books & Supplies estimates are based on average cost of books for ATC, MTC, and STC.

Living Expenses - Housing estimates are based on the average cost of a 2 bedroom/2 bath rental in Broward County.

Living Expenses - Food estimates are based on BCPS published reimbursement rate of \$64 for 3 daily meals.

Transportation estimated costs are based on the monthly vehicle operating costs for the Dade and Broward County region as listed in the IRS Local Transportation Standards publication.

Personal & Miscellaneous estimated costs are based on U.S. Bureau of Labor Statistics Consumer Expenditure data for the Miami area and includes the categories of apparel, entertainment, personal care and miscellaneous items.

Net Price Calculator

In accordance with the Higher Education Opportunity Act, each postsecondary institution that participates in Title IV federal student aid (FSA) programs must post a net price calculator on its website that uses institutional data to provide estimated net price information to current and prospective students and their families based on a student's individual circumstances. This calculator allows students to calculate an estimated net price of attendance at an institution which is defined as the cost of attendance minus the average yearly grant and scholarship aid.

Please note that the information provided by the calculator is a broad estimate. There are many factors that are considered as part of the financial aid award process, including full or part-time attendance, dependency status, grade level and application submission dates.

Return of Title IV Policies / Post Withdrawal Disbursements

Under the Higher Education Reconciliation Act (HERA), a student who voluntarily or involuntarily withdraws or otherwise ceases to attend the college will lose student financial aid eligibility and will not be paid further funds for the enrollment period but may be eligible to keep the funds received. The amount of Title IV grant assistance earned by the student must be determined by performing a Return of Title IV calculation. If the amount disbursed to the student is greater than the amount earned, unearned funds must be returned in accordance with federal HERA guidelines. The student is responsible for any tuition, fees, books or equipment that is not covered by Title IV funds. If the student receives less federal student aid than the amount earned, the student is eligible for a post-withdrawal disbursement.

Official Withdrawal

The instructor completes a change of enrollment form when a student voluntarily withdraws and informs the school of his intent to withdraw. The last day of recorded attendance will be listed as well as the student's withdrawal date. This information is necessary when completing the Return of Title IV (R2T4) form.

Unofficial Withdrawal

Involuntary withdrawals will follow the same process as above, but the day the student is officially withdrawn from the institution will be both the last day of attendance and withdrawal date.

Please be aware that students who withdraw prior to completing more than 60% of the payment period have not earned all of their federal financial aid. If the amount of Federal Title IV aid disbursed exceeds the calculated amount earned by the student, the institution must return a portion of the excess funds. If the return of funds creates a balance due on the student statement account, the student will be liable for satisfying the outstanding balance.

A student may receive a post-withdrawal disbursement if the calculated amount of Federal Title IV aid earned exceeds the amount disbursed.

Satisfactory Academic Progress (SAP) Policy

Students must maintain minimum standards of progress in accordance with the institutions' policies and federal regulatory requirements to be eligible to receive financial aid. Minimum standards refer to established qualitative and quantitative criteria, including a maximum timeframe within which a student must complete his/her program. Student progress is monitored by utilizing the Grade and Hours Report.

If a student's academic standing is not in accordance with the satisfactory standards stated below, the student's aid may be terminated.

> Qualitative Measure (Cumulative Grade Point Average)

A student's satisfactory progress is reviewed at the end of each payment period before an award is disbursed. A minimum cumulative grade point average (GPA) of 2.0 must be maintained, which is a grade of C. Students are reviewed for SAP changes before a disbursement is given. A failed course (F letter grade) must be successfully passed before moving onto another payment period.

> <u>Quantitative Standard (Completion Rate)</u>

Students must complete a minimum number of clock hours per program to be considered making progress. Students must demonstrate a pace/progress by completing at least 67% of the attempted clock hours in order to complete their program within the required timeframe allowed. If the student is behind in progress, the student may not complete on time. The quantitative measure is based on calendar time (weeks/months) since students are given credit for every hour of attendance.

Maximum Timeframe: Students must be progressing at a rate that enables them to complete their program within the Federal Regulation. The regulation specifies that the maximum timeframe may not exceed 150% of the advertised program length as set forth in the State Curriculum Frameworks.

Example

• A 900 clock hour program must be completed within 150% or 1350 clock hours.

Financial Aid Warning: Students must meet the minimum cumulative GPA of 2.0 or program GPA. If the student fails to meet the minimum GPA and/or complete at the proper completion rate, the student is placed in a Financial Aid Warning status. The Office of Financial Aid reviews each student record at the end of each payment period. Students who are not meeting SAP requirements will be notified by the Office of Financial Aid via phone or email that they have been placed in a financial aid warning status.

Students placed in a Financial Aid Warning status remain Title IV eligible for one payment period only. If, at the end of the payment period, the student is meeting SAP requirements the student will be placed in good standing and continue to remain eligible for Title IV funds. If, at the end of the payment period, the student is not meeting SAP requirements the student becomes ineligible for the next payment period and will remain ineligible for the next payment period until the student meets the SAP requirements at an official evaluation point. There is no appeal process or probation period.

Textbook Information

The Higher Education Opportunity Act requires postsecondary institutions to disclose certain information to their students. This information includes the required and recommended textbooks as well as supplemental materials for each course, including the International Standard Book Number (ISBN) and retail price information. Students can locate this information on the program cost sheet (brochure/flyer) or Excel spreadsheet which is located on the program page of each college website. Prices are an estimation and subject to change.

Transfer of Credit Policies

Students with previous technical training from other institutions may receive credit for that training. A transcript from a Florida public institution documenting course completion and/or occupational completion points achieved for a specific technical program will be accepted in transfer at the receiving institution for the same technical program. A transcript from a non-public institution that is fully accredited by a regional or national accrediting agency recognized by the United States Department of Education and that participates in the common course designation numbering system will be accepted in transfer at the receiving institution for the same technical program.

A transcript from a non-accredited institution will be evaluated on an individual basis by the department head, instructor, and program administrator to determine if advanced placement in a given program is applicable.

Articulation Agreements

The Broward Technical Colleges have partnered with Broward College and all State/Community Colleges to help students accelerate their career path. The student may be eligible to earn college credit if he/she has completed a career and technical education (CTE) program at one of the Broward Technical Colleges that align with <u>Broward</u> <u>College's Associate of Science</u> degree program(s) or those offered at one of the other 27 State Colleges.

Voter Registration

The Broward Technical Colleges comply with The Higher Education Amendments Act of 1998 which requires institutions to make a good faith effort to encourage students and staff to register to vote. This law requires that institutions of higher learning provide each enrolled student the opportunity to apply to register to vote or update their voter registration records at least once a year. Notice of Availability of Institutional and Financial Aid Information

The Office of Financial Aid provides assistance to eligible students who apply for financial aid and indicate one of the Broward Technical Colleges as the institution of choice on their Free Application for Federal Student Aid (FAFSA). In conjunction with the U.S. Department of Education and the Florida Department of Education, the technical colleges award aid from federal and state programs.

The financial aid program is designed to provide assistance to students who, without assistance, would be unable to attend school. It must be stated that the majority of the responsibility for financing a postsecondary education primarily rests with the student and/or parent. Financial assistance should be viewed only as supplementary to the financial aid resources of the student and the family. Any financial aid received is to be used exclusively for expenses related to attending one of our institutions.

Applying for Aid

Students can apply for financial assistance by completing and submitting the <u>Free Application for Federal Student</u> <u>Aid</u> (FAFSA) online or by requesting a paper FAFSA application by calling 1-800-433-3243. Assistance with the FAFSA is by calling the Federal Student Aid Information Center at 1-800-433-3243. Teletype Machine users or the hearing impaired may call 1-800-730-8913 for assistance when completing the FAFSA. The Broward Technical Colleges' Federal School Codes are:

Obtaining a Federal Student Aid ID

Financial Aid Eligibility

Financial aid eligibility is determined by the federal government after the student has applied for aid. <u>Eligibility</u> requirements for federal student aid can be found on the U.S Department of Education website. Eligibility requirements to apply for the State of Florida Grants and Scholarship Programs can be found on the website of the <u>Office of Student Financial Assistance</u>.



Student Loan Information

The Broward Technical Colleges do not participate in the federal student loan programs.

Professional Judgment – Special and Unusual Circumstances

Section 479A of the Higher Education Act gives financial aid administrators the authority to make case-by-case adjustments to data items used to calculate a student's eligibility for financial aid. Professional judgment determinations must be adequately documented in order to address current circumstances not reflected on the student's FAFSA.

What are Special and Unusual Circumstances?

"**Special circumstances**" refers to financial situations that may lead to a financial aid adjustment. This type of adjustment is called a Request for Professional Judgment.

Special circumstances could include one or more of the following:

- Loss or reduction of employment earnings
- Reduction or loss of untaxed income or benefits
- Loss of a one-time income distribution
- Death of a parent (dependent student) or spouse (independent student)

"Unusual circumstances" refers to conditions that may lead to an adjustment to a student's dependency status based on a unique situation. This type of adjustment is called a Dependency Override.

Unusual circumstances could include one or more of the following:

- Abusive family environment that threatens the student's health or safety
- Parental abandonment
- Parental incarceration
- Death of parent after filing the FAFSA when surviving parent meets one of the conditions above
- Human trafficking
- Refugee or asylee status
- Unaccompanied homeless youth status

Special and Unusual Circumstances Procedures

The Office of Financial Aid will make these adjustments only when appropriate to each student's situation with appropriate documentation. If you are experiencing special or unusual circumstances, contact your financial aid counselor to discuss your situation. If we determine that you may be eligible for an adjustment, we will advise you which of the below forms and types of documentation to submit.

Once your documentation is submitted, please allow 4 weeks for your request to be reviewed. We will contact you if we need any additional supporting information. You will be notified of the result of your request as soon as practicable after we have reviewed all requested documentation.

Please be aware of the following important information:

- Not every student who experiences special or unusual circumstances will be eligible for or benefit from a financial aid adjustment.
- If your FAFSA was selected for verification, this process must be completed before we can consider any special circumstances requests.
- A school is not permitted to make a professional judgment for a student after that student has ceased to be eligible, including when the student is no longer enrolled.
- The Office of Financial Aid's decisions regarding these requests are final and cannot be appealed to the Department of Education.

1. My parents don't support me financially. Am I eligible for a dependency override?

No. None of the conditions listed below, singly or in combination, qualify as unusual circumstances meriting a dependency override:

Parents refuse to contribute to the student's education. Parents will not provide information for the FAFSA or verification. Parents do not claim the student as a dependent for income tax purposes. Student demonstrates total self-sufficiency.

If the above conditions exist, you will be asked to add parental information to your FAFSA.

2. What are some examples of circumstances that do not warrant a professional judgment request?

Vacation expenses, expenses for home remodeling and renovation, and standard living expenses (e.g. utilities, credit card expenses, children's allowances, etc.) Normal income fluctuations also do not generally warrant a professional judgment request. The reduction in income must have been related to special circumstances. The Office of Financial Aid must make reasonable decisions that support the intent of the provision. Also, we will not consider for such requests any expenses that are already covered by the Income Protection Allowance which is included in the Student Aid Index (SAI) to account for living expenses.

3. I experienced a reduction in income. Am I eligible for a financial aid adjustment?

It depends. Not every student who experiences a reduction in income is eligible for or will benefit from a financial aid adjustment. For example, if your FAFSA already reflects the maximum financial need, the adjustment process may not provide any benefit. Your financial aid counselor will review your case to determine if a financial aid adjustment is appropriate.

4. What types of documentation will I be asked to submit?

It depends. Not every student who experiences a reduction in income is eligible for or will benefit from a financial aid adjustment. For example, if your FAFSA already reflects the maximum financial need, the adjustment process may not provide any benefit. Also, keep in mind that the reduction in income also needs to be caused by special circumstances. Many households experience normal income fluctuations which do not constitute special circumstances. Your financial aid counselor will review your case to determine if a financial aid adjustment is appropriate.

Drug and Alcohol Abuse Prevention Program

Any Broward County Public School adult student who suspects that he/she has a substance abuse and dependency problem is encouraged to seek assistance from the Drug Prevention Counselor identified at the school or to consult with the District Substance Abuse Counselor assigned to the district designee's office. The student is assured that such assistance will be provided with total confidentiality, and it may, with the student's consent, lead to confidential referrals to appropriate professional agencies in the community. Vaccination Policies

The Department of Education requires institutions that participate in the federal student aid programs authorized under Title IV of the Higher Education act to make available to current and prospective students information regarding the placement in employment of, and types of employment obtained by, graduates of the institutions degree or certificate programs.

The Florida Education and Training Placement Information Program (FETPIP) provides follow-up data on previously enrolled Broward Technical College students who have graduated, exited or completed a public education or training program within the State of Florida.
